CALL TO ORDER: President Ellis called the meeting to order at 7:00 pm

TREASURER'S REPORT: The treasurer's report for June/July/August was presented.

FOR DECISION: Hazan and Sygall – Airbnb rentals

Susan Hazan, 1001 E Via Soledad, presented to the Board a letter explaining why she is renting out her guest house to Airbnb clients. Adam Hazan explained that his mother would not be able to remain in the home if she couldn't rent out the guest house. He also said that the covenants can be enforced at the discretion of the Board and hopes that his mother will be allowed to continue renting It was explained that, although the Board has latitude, the overarching responsibility is to enforce the will of the membership as prescribed in the Covenants. Adam Hazan asked what the process was to change the covenants. It was explained that it required a petition signed by 25% of the membership before it could be put before the entire membership for a vote to change any part of the Covenants and that it would require 51% of the membership to affect a change. They would like to canvas the neighborhood and get enough signatures so that it can be brought before the membership for a vote. Adam also said they were willing to find out what other HOAs are doing in regard to Airbnbs. A motion was made that both Hazan and Sygall (who did not show up for his hearing) will be fined \$40 per week until they close down their Airbnbs.

Beeston/McCarthy, 1850 E Calle Del Cielo, Ken explained that their mailbox post isn't in compliance. The Beeston/McCarthy said when they bought the house 12 years the post was like that. They will be submitting a variance application.
